



## **COVID-19 Safety Policy**

WISH Community school and WISH Academy are both located on a property owned by the Los Angeles Unified School District. WISH Community and Academy are also charter schools authorized by the Los Angeles School District. As such, WISH is subject to and fully complies with the Los Angeles Unified COVID-19 safety plan, operations and facilities agreements, FUA., and all guidance distributed to LAUSD schools and required of folks who are co-located. All LAUSD COVID-19 policies will be followed by all students, staff, faculty, and folks entering campus.

The aforementioned LAUSD approved policies are shared and linked below along with information about the most recent amendment to the student policy made on December 14, 2021, LAUSD Special Board Meeting requiring all district-approved charter schools to post their vaccine policies, COVID safety plans, and COVID testing/case data.

As an entity subject to the LAUSD COVID-19 safety, operations, and exposure management plans WISH requires:

- All employees, on-campus workers, and volunteers to follow the safety plans and updated guidance from LAUSD listed on our website and updated upon receipt of LAUSD inter-office correspondence.
